Sealed bids for **OMB/DFM Contract No. MC1002000294 – Division of Forensic Science – Packaged Rooftop Unit Replacement** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Tuesday, January 5, 2016, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves replacement of the packaged rooftop air handling units located at the Division of Forensic Science building in Wilmington, Delaware.
