# AMOCO BUILDING - BASEBOARD HEAT UPGRADE OMB/DFM CONTRACT #'S MC1002000365 ADDENDUM #2

### **QUESTIONS:**

- A. Can you confirm that owner will be moving furniture as needed for this work to be complete? The contractor will be responsible for moving the furniture as needed for the work to be complete.
- B. M-300, detail 2 shows a back-up plate. Is this to be installed on the building façade? The "Back Up" plate is intended to be utilized on an interior wall. The piping on this project is expected to be hung from the structure above as indicated on details 3 and 4 of M-300.
- C. Are new radiators being piped straight through as shown on M-301, or is a HWS/R header being run as shown in M-300, detail #1?
  - The radiators are to be piped as shown in detail #1 of M-300. Two additional details (#5 & #6) have been added to drawing M-300 for additional clarification.
- D. M-300, detail 1 shows 2 HWR lines. Are these new HWR lines to run within new baseboard cabinets? This conflicts with overhead view shown on M-100.
   M-100 shows where the baseboard piping is intended to be routed in the ceiling and where drops are intended to occur. Detail #1 on M-300 shows how the baseboard piping is intended to be routed in the baseboard cabinets. Two additional details (#5 & #6) have been added to drawing M-300 for additional clarification.
- E. Alternate 1 description in the specifications section 01 23 00 is not the same as Alternate #1 on the bid form that was provided via Addendum #1. Please advise

  A revised specification section 01 23 00 is included in this addendum.
- F. Will any of the project need to be performed on off hours?

  No. Work areas to be coordinated via the contractor's schedule presented at the kick off meeting. The building occupants will be scheduled to be out of the specific work areas while work occurs. The expectation is that work will occur in most offices in less than a day.
- G. Will any of the rooms be occupied during construction?

  The entire building will be occupied during construction. However with the exception of rooms 141 thru 143 the occupants within the rooms under construction are intended to be in another portion of the building.

H. Bid documents call for remove and replacement of any furniture. There was several rooms with personal items in the work area (wall décor, pictures on desks, etc.) Will these items be removed by the occupant of the room?

The owner will be clearing off the desks and removing electronics from the offices. The contractor shall move the furniture as necessary for work to occur.

I. Will expansion fittings be required?

Yes. The contractor shall install an expansion fitting for every 75 feet of straight pipe. Expansion fitting shall be equal to Metraflex HPFF2.

J. What is the basis of design for the sink? See revised M-300 for sink schedule.
