

## ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC1002000371 – Kent County Fire Marshal’s Office – Cooling Tower Replacement** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:30 p.m. local time on Thursday, July 20, 2017, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the replacement of the existing closed circuit cooling tower at the Kent County Fire Marshal’s Office in Dover, Delaware.

A **MANDATORY** Pre-Bid Meeting will be held on Wednesday, July 5, 2017, at 9:00 a.m. in the conference room at the Kent County Fire Marshal’s Office, 1537 Chestnut Grove Road, Dover, Delaware, for the purpose of establishing the list of subcontractors and to answer questions.
