

## ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC1002000391 – Division of Forensic Science – Emergency Generator Replacement** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (3<sup>rd</sup> Floor), Dover, DE 19901 until 2:30 p.m. local time on Friday, November 17, 2017, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

The project involves replacement of the existing standby generator at the Division of Forensic Science in Wilmington, Delaware, to support the existing connected loads as well as proposed additional loads, in addition to exterior improvements and electrical infrastructure upgrades.

A **MANDATORY** Pre-Bid Meeting will be held on Wednesday, November 1, 2017, at 9:00 a.m. in the first floor conference room of the Division of Forensic Science, 200 South Adams Street, Wilmington, Delaware, for the purpose of establishing the list of subcontractors and to answer questions.
