CLARIFICATIONS:

- 1. Contractors working inside the building are required to obtain a background check at their own expense. Please see https://ca.fadv.com/CA/DTI for additional information. Clearance will be determined by DTI management. The DTI Criminal Background Checks User Guide is included with this addendum.
- 2. The contractor shall minimize the heat pump loop shut down time. In order to accomplish this it is anticipated that pumps will be replaced one at a time and that the contractor will provide a temporary means to maintain the condenser water loop operational while the existing tower is being removed and the new tower is installed.

QUESTIONS:

1. Please clarify the plan for taking down the fence, can the fence remain open during the entire duration of the project?

Answer: The fence is not to be taken down for security concerns. It is anticipated that the existing tower is to be removed and the new tower is to be installed utilizing the existing gates and/or a mechanical lift.

2. On the attached M100, please verify the pipe highlighted. Answer: This pipe has been removed from the drawing.




