

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC1002000410 – Carvel State Office Building – Roof Top Anchors** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (3rd Floor), Dover, DE 19901 until 2:00 p.m. on Tuesday, August 7, 2018, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

The project involves the following at the Carvel State Office Building in Wilmington, Delaware: furnishing and installing 48 roof top anchors for use by suspended maintenance platforms and window washing scaffolding. Includes drilling of existing concrete deck, removal of existing roof system at anchor locations and replacement of roof system upon installation completion. Installation and testing certification to be done in accordance with OSHA regulations.

A **MANDATORY** Pre-Bid Meeting will be held on Monday, July 23, 2018, at 10:00 a.m. in the Facilities Management Conference Room located on the first floor of the Carvel State Office Building, 820 N. French Street, Wilmington, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**
