

**ADVERTISEMENT FOR BIDS
RE-BID**

Sealed bids for **OMB/DFM Contract No. MC1002000432 – Carvel State Office Building – First Floor and Mezzanine – Restroom Renovations – Re-Bid** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Wednesday, December 18, 2019, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

The project involves renovating the restrooms located on the first floor and mezzanine at the Carvel State Office Building located in Wilmington, Delaware, such that they meet ADA accessibility and current building codes. As part of the renovation, all finishes are to be updated to match other restrooms in the building; fixtures are to be replaced with more efficient ones, and lights are to be replaced with new LED fixtures.

A **MANDATORY** Pre-Bid Meeting will be held on Wednesday, November 27, 2019, at 1:00 p.m. in the Facilities Management conference room located on the first floor of the Carvel State Office Building, 820 N. French Street, Wilmington, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**

Sealed bids shall be addressed to the Division of Facilities Management, Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901. The successful bidder must post a performance bond and payment bond in a sum equal to 100 percent of the contract price upon execution of the contract. The Owner reserves the right to reject any or all bids and to waive any informalities therein. The Owner may extend the time and place for the opening of the bids from that described in the advertisement, with not less than two calendar days notice by certified delivery, facsimile machine or other electronic means to those bidders receiving plans.
