

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC1002000461 for the Absalom Jones Gymnasium Floor Renovations** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, by either electronic mail or by mail as follows. Bid submissions submitted by electronic mail must be sent to DFM-BID@delaware.gov and a hard copy of the entire submission shall be sent by mail, but the hard copy does not have to arrive prior to bid submission

Sealed bids shall be mailed and addressed to the Division of Facilities Management, Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901. The outer envelope should clearly indicate: **“OMB/DFM CONTRACT NO. MC1002000461 – ABSALOM JONE GYMNASIUM FLOOR - SEALED BID - DO NOT OPEN.”**

Bids will be accepted until 2:00 p.m. local time on Wednesday, May 6, 2020. Bids will be opened and read aloud at 2:30 p.m. local time on Wednesday, May 6, 2020. Bidder bears the risk of late delivery. Any bids received after the stated time whether by mail or electronic mail will be rejected and the mailed bids will be returned unopened. The bid opening will be held through electronic means to comply with the Governor’s State of Emergency. The project involves the removal and replacement of the gymnasium flooring with new fluid-applied athletic floor, selective demolition, floor leveling compound, painting and gymnasium equipment at the Absalom Jones Community Center, 310 Kiamensi Road, Wilmington, Delaware.
