

## ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC2006000095 – Cooch Dayett Millers House – Exterior Stabilization** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 11:00 a.m. local time on Tuesday, July 10, 2018, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves miscellaneous repairs to the exterior envelope of the house including repair of existing wood windows, repair of existing wood trim, minor repair of existing masonry and installation of new storm windows. Work also includes repair/replacement of existing first floor wood framing plus subfloor and finished wood floor at the Cooch Dayett Millers House, located at 2029 Sunset Lake Road, Newark, Delaware.
