The purpose of the meeting was to review the intended scope, and other documents for bidding the work.

The topics discussed were as follows:

- 1.01 Bernardon reviewed the scope of the project noting that it involved the replacement of the existing cedar shingle roof, miscellaneous masonry repair, miscellaneous wood window sill repair, miscellaneous wood cupola repair. As well as other minor repairs indicated in the contract drawings and specifications dated 06/14/17.
- 1.02 Bernardon stated that this was a pre-bid meeting for the roof replacement at the Academy building in New Castle. All were requested to sign in on the provided sign-in sheet (see attached) and if they did not sign in they would be considered absent and not allowed to bid the project. It was stated that bids were due Friday, July 28, 2017 by 11:00am at OMB's office in the Thomas Collins Building, 540 S. DuPont Highway, Dover, DE. It was stated that the last day for questions would be close of business Friday, July 21, 2017 with the last addendum would be issued via e-mail by close of business Monday, July 24, 2017.
- 1.03 Bernardon stated that there is an alternate price requested for a design/build lightning arrestor system.
- 1.04 Bernardon stated that the light fixtures indicated by note "R7" on sheets A-101 and A-102 are to be salvaged and turned over to the Tenant of the Academy. It was indicated by HCA that the power to these fixtures has already been disconnected.
- 1.05 Bernardon stressed that Bidders review spec section 01 10 00 SUMMARY, specifically paragraph 1.8 Work Restrictions as well as Section 01 14 00 WORK RESTRICTIONS.
- 1.05 BRS stated that the specs call for the shingles to be warranted per CSSB's standard warranty. However CSSB will not warrant shingles in Delaware unless preservative treated. Bernardon to clarify what should be done.
- 1.06 BRS stated that the specs call for replacement lath to be bald cypress. Bald cypress is an endangered species in the state of Delaware. Is there some other species that could be used, Bernardon will verify.

- 1.07 DFM reminded all Contractors present to make sure they include in their bid package a copy of their license and their drug testing affidavit. Without these, their bids will be rejected.
- 1.08 The question was raised if this project was or would need to be reviewed by the New Castle Historic Commission. Bernardon stated that they had been in contact with the City of New Castle building inspector (Jeffrey Bergstrom) and was told that it was with-in his authority to approve this work without it going before the commission and that verbal approval from the building inspector had been granted.

 - A. Cedar Roof Shingles: Red Cedar Tapersawn Shakes, sawn both sides, Number One Premium Grade, 24-inch length by 5/8-inch thickness, 100% end grain having the Certi-Last label for preservative treatment.
- 2. Section 07 31 29 WOOD SHINGLE ROOFING; paragraph 2.1, E revised to read:
 - E. Replacement wood lath: 1-inch full thickness by 2-1/2 inches wide, bald cypress or rough sawn white pine.
