

## ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC3501000018 – Holloway Campus – Kent/Sussex Building – Loading Dock Repairs**, will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in Room 011 of the Main Building Annex of the Herman Holloway Campus, 1901 N. DuPont Highway, New Castle, DE 19720 until 2:00 p.m. local time on Friday, October 10, 2014, at which time they will be publicly opened and read aloud. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the replacement of the loading dock ramp, relocation of dumpster pad, cart storage, oxygen tank storage, new retaining wall, new access ramp and accessible path, and drainage improvements at the Kent/Sussex Building on the Herman Holloway Campus located in New Castle, Delaware.
