

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC3501000033 – Holloway Campus – Biggs Building - Boiler Replacement** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Wednesday, September 16, 2015, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the installation of three boilers with their associated pumps, ductwork, piping, controls, etc., and the installation of one new loop pump and replacement of two loop pumps at the Biggs Building located at the Herman Holloway Campus in New Castle, Delaware.
