Sealed bids for **OMB/DFM Contract No. MC3501000044 – Holloway Campus – Springer Building – Boiler Replacement** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:30 p.m. local time on Thursday, July 27, 2017, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the replacement of the existing cast iron hot water boilers with two (2) new condensing type heating hot water boilers at the Springer Building on the Herman Holloway Campus in New Castle, Delaware.
