

**ADVERTISEMENT FOR BIDS
RE-BID**

Sealed bids for **OMB/DFM Contract No. MC3501000045 – Holloway Campus – Administration Building – Chimney Repointing and Repairs – Re-Bid** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Thursday, May 11, 2017, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Work to be accomplished under the base bid in accordance with this contract includes repointing of six (6) selected chimneys at the DHSS Administration Building at the Holloway Campus in New Castle, Delaware. Job will be performed from a crane or lift, no materials or persons will be permitted on the existing slate roof. Work also includes brick and concrete cap replacement as needed. Personnel lifts as well as cranes will be required to put materials and personnel at the six chimney locations.

A **MANDATORY** Pre-Bid Meeting will be held on Tuesday, April 25, 2017, at 9:00 a.m. in the conference room of the Administration Building Annex at the Holloway Campus, 1901 N. DuPont Highway, New Castle, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**

Sealed bids shall be addressed to the Division of Facilities Management, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901.
