Sealed bids for **OMB/DFM Contract No. MC3501000048/52 – Holloway Campus – Fire and Domestic Water Booster Pump Replacements – Re-Bid** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Tuesday, May 9, 2017, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the expansion of the current pre-engineered pump house building, replacement of the existing diesel driven fire pump and piping, replacement of the existing domestic water booster pumps and piping, underground site work to separate fire and domestic water services, electrical, diesel fuel systems, BAS controls, carpentry and concrete at the Holloway Campus located in New Castle, Delaware.
