

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC3501000048 – Holloway Campus – Fire and Domestic Water Booster Pump Replacements** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Friday, March 17, 2017, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves replacing the existing diesel driven fire pump and electrical domestic water booster pumps in kind at the Herman Holloway Campus located in New Castle, Delaware. Work includes above ground and underground piping site work, extension of the existing building, electrical, diesel fuel systems and BAS controls.
