

ADVERTISEMENT FOR BID

Sealed bids for **OMB/DFM Contract No. MC3501000054 – Milford State Service Center – Annex Renovations** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 1:00 p.m. local time on Thursday, February 15, 2018, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the renovation of approximately 2,000 square feet of office space at the Milford State Service Center in Milford, Delaware. Scope of work will include the removal of flooring, casework and walls and other items as indicated. New finishes, casework, interior windows, doors and other indicated items will be constructed. Scope of work for all related plumbing, electrical, mechanical and other appurtenances will be a design-build.

Front Street, Milford, Delaware, for the purpose of establishing the list of subcontractors and to answer questions.
