Sealed bids for **OMB/DFM Contract No. MC3501000062 – Adams State Service Center – Window Replacement – Phase II** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Thursday, June 27, 2019, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project includes removal and replacement of existing windows, soffit repair, minor brick repair, and window treatments at the Adams State Service Center in Georgetown, Delaware.
