

## ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC3501000083 – Holloway Campus Fire Alarm Monitoring System Replacement** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, by either electronic mail or by mail as follows. Bid submissions submitted by electronic mail must be sent to [DFM-BID@delaware.gov](mailto:DFM-BID@delaware.gov) and a hard copy of the entire submission shall be sent by mail within five (5) business days of the bid submission deadline.

Sealed bids shall be mailed and addressed to the Division of Facilities Management, Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901. Bids will be accepted until 12:30 P.M local time on Thursday, August 20, 2020. Bids will be opened and read aloud at 1:00 P.M. local time on Thursday, August 20, 2020. Bidder bears the risk of late delivery. Any bids received after the stated time whether by mail or electronic mail will be rejected and the mailed bids will be returned unopened. The bid opening will be held through electronic means to comply with the Governor’s State of Emergency.
