

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC3501000085 – Holloway Greenhouse Roof Panel Replacement** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, by either electronic mail or by mail as follows. Bid submissions submitted by electronic mail must be sent to DFM-BID@delaware.gov and a hard copy of the entire submission must be received by mail within five (5) business days of the bid submission deadline.

Sealed bids shall be mailed and addressed to the Division of Facilities Management, Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901. The outer envelope should clearly indicate: **OMB/DFM CONTRACT NO. MC3501000085- Holloway Greenhouse Roof replacement**

Bids will be accepted until 10:45 AM local time on Monday, November 9, 2020. Bids will be opened and read aloud at 11:30 AM local time on Monday November 9, 2020. Bidder bears the risk of late delivery. Any bids received after the stated time whether by mail or electronic mail will be rejected and the mailed bids will be returned unopened. The bid opening will be held through electronic means to comply with the Governor's State of Emergency. To attend the bid opening, the public may participate by joining the meeting at Webex.com, meeting number **173 009 0071** and password **qRRrY7Uqv75**. There will be no in-person meeting.

The project involves the following at the Greenhouse at Herman Holloway Campus located in New Castle, DE: removal and replacement of the roof and wall panels, exterior door, garage door, gutter coating, metal grate, pipe penetrations, and fan enclosures. As an alternate, there is electrical work for exterior lights.

In compliance with the Governor's State of Emergency, the pre-bid meeting will be held by electronics means. There will be no in-person meeting.
