Sealed bids for **OMB/DFM Contract No. MC3511000027 – Stockley Center – All Star Building – Toilet Room Renovations** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Thursday, March 3, 2016, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves ADA upgrades to the toilet rooms of the All Star Building located at the Stockley Center in Georgetown, Delaware.
