Sealed bids for **OMB/DFM Contract No. MC3511000028 – Stockley Center – 102BB Building Renovations** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 10:00 a.m. local time on Thursday, October 20, 2016, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the following at 102 Boyd Boulevard at the Stockley Center located in Georgetown, Delaware: building renovations to provide facilities for proposed reuse as a day care facility including, but not limited to, ADA bathroom conversions, new interior finishes, new lighting, new mechanical work for a kitchen, and fire suppression system.
