Sealed bids for **OMB/DFM Contract No. MC3511000030 – Stockley Center – Williams Cottages – Building Demolition – Re-Bid** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 1:00 p.m. local time on Thursday, October 26, 2017, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project includes the following at the Stockley Center in Georgetown, Delaware: complete demolition of five (5) buildings; re-grading and seeding of impacted areas and site restoration; disconnecting/capping telephone, gas, water and sewer lines and any others as applicable; haul off all debris.
