Sealed bids for **OMB/DFM Contract No. MC3511000030 – Stockley Center – Williams Cottages – Electric Relocation** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 10:30 a.m. local time on Tuesday, September 12, 2017, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project includes the following at the Stockley Center in Georgetown, Delaware: disconnect and remove existing secondary electric switchgear and services serving Williams Cottages W2, W3 and W4; provide new 25kV switchgear, pad mount transformer and secondary distribution equipment for the Gehrt Building; provide concrete and asphalt paving.
