

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC3511000034 – Stockley Center – MAC Center – Hot Water Boilers Gas Conversion** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 10:30 a.m. local time on Tuesday, October 3, 2017, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project includes the following at the MAC Center at the Stockley Center in Georgetown, Delaware: replacing two (2) electric hot water boilers and one (1) electric domestic hot water heater with gas-fired units, circulating pump replacement and converting the boiler room from electric to natural gas. Work also includes miscellaneous piping, insulation and electrical work.
