- 9. Contractor to provide floor and wall finish protection as required.

The scope of work consists of the replacement of elevator equipment with new components in the elevator, elevator machine room, and elevator pit. Also there is work performed at each floor outside the elevator doors. Refer to specifications 14 20 10 Passenger Elevator for more detail of scope

 - c. Employee drug testing form is required from general contractor.
 - d. Acknowledge all addendums as individual items.
 - e. Include a copy of your business license, not just a number.
- 4. Review Sub Contractor List
 - a. Electrical, Plumbing, Elevator (to be updated via addendum)
- 5. Review Alternates
 - a. Alternate #1: Upgrade interior of elevator cab by replacing wall panels, railing, and flooring (specifications note 3 alternates, not correct, will clarify via addendum #1)
- 6. Review Allowances
 - a. Allowance: \$15,000 (revised per addendum #1)
- 7. Prevailing Wage Project
 - a. Rates included in specifications.
- 8. Schedule
 - a. Anticipate prompt award and commencement after bids are received.
 - b. Substantial completion by end of December.
- 9. Lay Down Area, Security and Occupancy
 - a. Laydown space is limited and materials will likely need to be brought offsite to the project site.



- b. All immediate areas adjacent to construction will be occupied for the duration of the project by staff. Contractor to provide all measures for pedestrian control and safe occupant passage for project duration.
