

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC3512000011 – Northeast State Service Center – Elevator Modernization** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 1:00 p.m. local time on Tuesday, August 7, 2018, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the modernization of the elevator at the Northeast State Service Center in Wilmington, Delaware. The scope of work consists of the replacement of elevator equipment with new components in the elevator, elevator machine room and elevator pit. Also there is work performed at each floor outside the elevator doors. Refer to specifications section 14 20 10 Passenger Elevator for more detail. The elevator serves three levels: the main egress level; one-half story above the egress level; and one-half story below the egress level.

A **MANDATORY** Pre-Bid Meeting will be held on Thursday, July 19, 2018, at 10:30 a.m. in the conference room of the Northeast State Service Center, 1624 Jessup Street, Wilmington, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**

Sealed bids shall be addressed to the Division of Facilities Management, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901.
