

## ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC3512000012 – Hudson State Service Center – Elevator Renovation** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 1:30 p.m. local time on Wednesday, July 11, 2018, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project includes the following at the Floyd I. Hudson State Service Center in Newark, Delaware: selective demolition of an existing elevator and installation of a new machineromless, holeless, hydraulic elevator that will serve three stories. Work includes new elevator cab, equipment controls and accessories required for a complete installation as well as GWB shaft infill and repair and associated architectural, mechanical, plumbing and electrical work.

Hudson State Service Center, 501 Ogletown Road, Newark, Delaware, for the purpose of establishing the list of subcontractors and to answer questions.
