Each bidder shall include signed Affidavit(s) for the Bidder and each listed Subcontractor certifying compliance with OMB Regulation 4104 "Regulations for the Drug Testing of Contractor and Subcontractor Employees Working on "Large Public Works Projects." "Large Public Works" is based upon the current threshold required for bidding Public Works as set by the Purchasing and Contracting Advisory Council.
 - d. Make sure you identify the project name and number on the front of your envelope when you submit your bid.

- a. All questions must be submitted in writing and must be faxed to DEDC, LLC, Attn: John Farina, Fax 302 738-7175 or E-mailed to jfarina@dedc-eng.com. Phone calls will not be accepted.
- b. All permits required for this effort to be obtained by the contractor.
- c. The General Contractor who is bidding the project shall have a full time superintendent or working foreman.
- d. This is a Delaware Prevailing Wage project (New Castle County).
- e. Work hours are 8:00 a.m. to 4:30 p.m.
- f. Contractor shall furnish and install a separation wall in the resident common area to split the left side resident bedrooms from the right side resident bedrooms for construction phasing. Separation wall shall be from FFE to Ceiling, structural member 2'O.C. with braces at top of wall to underside of Roof deck or structural member 32" O.C. wall sheathing no less than 1/2" plywood. The project will need to be done in (3) phases to allow half of the resident bedrooms to be available for occupancy during construction. The first phase of construction will include bathrooms on the left side of the Resident area (Toilet Rom 01, Toilet Room 2-3, Toilet Room 4-5, Toilet Room 6-7, Toilet Room 8-9, and Admissions Toilet Room 103). The second phase will include bathrooms on the right side of the resident area (Toilet Room 10-11, Toilet Room 12-13, Toilet Room 14-15, and Toilet room 16-17). The third phase will be to renovate the (2) staff bathrooms (Women's 108, and Men's 107). There will be a portable shower/restroom trailer on site behind the building (furnished and installed by Owner in separate contract) for resident use during the entire construction period.

C. Subcontractor Listing

- 1. There are now (3) subcontractor listings on this project: Plumbing, Carpentry, and Electrical. These Subcontractors are identified on the attached bid form.
- 2. Be sure to list your company name if your company is performing this work.
- 3. All companies listed must be registered in the State of Delaware to perform this work.

D. Allowances

1. There is a \$25,000 allowance on this project that shall be included in the base bid to cover miscellaneous items found during construction.

E. Meetings

- 1. There will be progress meetings on this project every 2 weeks on a specific day and time, to be determined at the kick off meeting.
- 2. Contractors shall provide 3 week look ahead schedule at each meeting to indicate work areas and shut downs.
