Sealed bids for **OMB/DFM Contract No. MC3514000005 – Bissell Hospital – Emergency Generator Replacement** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in Room 011 of the Main Building Annex of the Herman Holloway Campus, 1901 N. DuPont Highway, New Castle, DE 19720 until 1:00 p.m. local time on Thursday, October 17, 2013, at which time they will be publicly opened and read aloud. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves removal of two existing emergency generators and replacement with one new 450 KW generator with associated switches and gear at the Emily P. Bissell Hospital located in Wilmington, Delaware.
