

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC3514000026 – Governor Bacon Health Center – Tilton Building – Fan Coil Unit Replacement** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Wednesday, August 2, 2017, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the installation of a new dual temperature piping loop in preparation for future fan coil replacements at the Tilton Building at the Governor Bacon Health Center in Delaware City, Delaware. Additionally, various fan coil units will be replaced in this project.
