

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC3514000032 – Governor Bacon Health Center – Tilton Building – Parking Lot Expansion** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in Room 011 of the Main Building Annex of the Herman Holloway Campus, 1901 N. DuPont Highway, New Castle, DE 19720 until 2:00 p.m. local time on Thursday, July 21, 2016, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the following at the Governor Bacon Health Center located in Delaware City, Delaware: expansion of the Tilton Building parking lot; mill and overlay of Brady Road; additional pavement at the New Castle Avenue entrance.
