Dover, DE 19901, (Attn: Patrick McKenna) as described in the Invitation to Bid of the specifications.
 - 2. Bid Opening Wednesday, August 17th, 2016 at 10:00 a.m.
 - 3. Questions and substitution submission deadline Thursday August 11th, 2016.
 - 4. An optional secondary walk through has been scheduled for Monday, August 8th, 2016 at 9:00 a.m. Contractors shall meet in the Lobby and be escorted by Maintenance.

B. Key topics

- 1. Bids
 - a. The contractor must use the bid form supplied in the specifications. The bid form must be submitted in triplicate
 - b. Make sure you identify your project name on the front of your envelope when you submit your bid.

 - d. Provide a copy of the prime contractors Delaware Business License with the bid.

- 3. General
 - a. All questions must be submitted in writing and must be faxed to DEDC, LLC, Attn: John Farina, Fax 302 738-7175 or E-mailed to jfarina@dedc-eng.com. Phone calls will not be accepted.
 - b. All permits required for this effort to be obtained by the contractor.
 - c. Work hours shall be 7:00 a.m. to 4:00 p.m. Monday thru Friday for contractors on site.
 - d. Contractor to have full time superintendent or working foreman.
 - e. There are (4) subcontractor listings on this project: Mechanical, Electrical, Controls, and Site Work. Be sure to list your company's name if your company is preforming the work.
 - All companies listed must be registered in the State of Delaware to perform this work.
 - f. The building will be fully occupied during the construction of this project.
 - g. This is a Prevailing Wage project (New Castle County).
- C. Scope of Work, Alternates, and Allowances:
 - 1. Scope of work was described as written on Sheet M000 of Bidding Documents.
 - 2. Alternate #1 and #2 were described as written on Sheet M000 of Bidding Documents.
 - 3. Allowances were described as written on Sheet M000 of Bidding Documents.

 - 1. There will be progress meetings on this project every 2 weeks on a specific day and time, to be determined at the kick off meeting.
 - 2. Contractors shall provide 3 week look ahead schedule at each meeting to indicate work areas and shut downs.
- E. Addendum #01- Revisions to Bidding Documents:
 - 1. The Bid Form has been Revised to include the Bid Due Date at top of Form, and to include the change as described in E-2, below. The revised version is included in this Addendum.
 - 2. The Bidding Documents indicated that the Contractor must secure the services of Amerigas for the work associated with the installation of four (4) new 1000-Gallon Propane Tanks. This shall be revised to allow for the Contractor to secure the service of his choice of Propane Vendor, as long as the work to be performed is equal to that described in the documents. The \$10,000.00 allowance shall remain for this work.
 - 3. MD100 shows that the abandoned fuel oil tank is to be demolished by the contractor. The tank has already been removed and should not be included in the bid. However, Keyed Note #1 still applies for the removal of the abandoned fuel oil piping.
