Sealed bids for **OMB/DFM Contract No. MC3514000039 – Governor Bacon Health Center – Tilton Building – South 1 Nurses Station – Re-Bid** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Tuesday, December 5, 2017, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project includes the following at the Tilton Building at the Governor Bacon Health Center in Delaware City, Delaware: demolition of an existing Nurses Station, Patient Room and two offices as required for construction of a new Nurses Station, Head Nurse Office, two new offices and new Resident Lounge. A Medication Room and Staff Rest Room will also be renovated. Two additional toilets, lavatories and associated piping will also be removed. The facility shall remain in operation throughout all construction activities.

A **MANDATORY** Pre-Bid Meeting will be held on Thursday, November 16, 2017, at 10:30 a.m. in the cafeteria in the Tilton Building, Governor Bacon Health Center, 248 Kent Avenue, Delaware City, Delaware, for the purpose of establishing the list of subcontractors and to answer questions.
