

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC3514000041 – Delaware Hospital for the Chronically Ill – Medical Building - Window Replacement** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 1:00 p.m. local time on Tuesday, March 6, 2018, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the following at Delaware Hospital for the Chronically Ill located in Smyrna, Delaware: removal of the old metal windows which will be done by the abatement contractor (who will be under a separate purchase order); a number of windows will be removed per day on second shift. The general contractor will coordinate with the abatement contractor for temporary security enclosures of the window openings. General contractor will come in the following day and install the windows and trim for the windows that were removed the night before. General contractor will be responsible for a complete window installation which includes windows, window trim (inside and out), caulk and paint.

A **MANDATORY** Pre-Bid Meeting will be held on Thursday, February 15, 2018, at 10:00 a.m. in the DHCI Maintenance Office at the Delaware Hospital for the Chronically Ill, 100 Sunnyside Road, Smyrna, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT. All attendees must check in at the front reception desk in the Prickett Building after which time directions will be given to the pre-bid meeting location.**

Sealed bids shall be addressed to the Division of Facilities Management, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901.
