INVITATION TO BID**

Sealed bids for **OMB/DFM Contract No. MC3514000054 – Prickett Building Domestic Water Piping Replacement Re-Bid** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, by either electronic mail or by mail as follows. Bid submissions submitted by electronic mail must be sent to DFM-BID@delaware.gov and a hard copy of the entire submission shall be sent by mail within five (5) business days of the bid submission deadline.

Bids will be accepted until 12:45 p.m. local time on Wednesday, August 26, 2020. Bids will be opened and read aloud at 1:30 p.m. local time on Wednesday August 26, 2020. Bidder bears the risk of late delivery. Any bids received after the stated time whether by mail or electronic mail will be rejected and the mailed bids will be returned unopened. The bid opening will be held through electronic means to comply with the Governor's State of Emergency. To attend the bid opening, the public may participate by joining the meeting at Webex.com, meeting number **129 009 9050** and password **CmEqrKiP757**. There will be no in-person meeting.

The project involves the replacement of the Domestic Water lines system in the Prickett Building in Smyrna Delaware.

The successful bidder must post a performance bond and payment bond in a sum equal to 100 percent of the contract price upon execution of the contract. The Owner reserves the right to reject any or all bids and to waive any informalities therein.
