Sealed bids for **OMB/DFM Contract No. MC3705000041 – New Castle County Detention Center – New Storage Building – Re-Bid** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 1:00 p.m. local time on Monday, December 18, 2017, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project includes, but is not limited to, the construction of a new 2,160 s.f., one story, pole barn building for the storage and maintenance of small equipment. Work includes concrete slabs, wood structure, metal siding and roofing, aluminum-clad wood windows, plumbing, electrical and HVAC.
