

## ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC3705000065 – New Castle County Detention Center – Furniture Replacement and Finish Renovations** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 1:00 p.m. local time on Wednesday, July 11, 2018, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

The project involves the following at the New Castle County Detention Center located in Wilmington, Delaware: removal of existing resident room furniture and replacement with new furniture; removal of existing low walls in resident rooms with toilets; new finishes in resident rooms - removal of existing VCT flooring and carpet and installation of new EVT flooring and painted walls, doors and door frames at resident room interiors.
