Sealed bids for **OMB/DFM Contract No. MC3804000010 – Sussex Correctional Institution – Closed Custody/Maximum Security - Fire Alarm System Replacement – Re-Bid**, will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 3:00 p.m. local time on Friday, January 20, 2012, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the following at the Sussex Correctional Institution located in Georgetown, Delaware: a new and complete non-proprietary Digital Addressable Fire Alarm System including, but not limited to, all required control panels and annunciator panels, notification, alarm, smoke and heat detection devices, duct smoke detectors, wiring, power supplies, systems tests; complete removal of the existing Fire Alarm System after installation of new, fully-operational system.
