

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC3804000028 – Sussex Work Release Center – Emergency Generator Replacement** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Wednesday, June 12, 2013, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the removal of the existing emergency standby generator that serves the Sussex Work Release Center located in Georgetown, Delaware. Project includes furnishing and installing a new emergency standby generator sized to handle all of the current loads of the Sussex Work Release Center plus the addition of the kitchen loads; furnishing and installing a new galvanized steel service platform around the new generator; furnishing and installing a new automatic transfer switch; providing a new concrete pad for the generator; furnishing and installing a new fence with gate around the generator.

Attention is called to construction schedule as detailed in the Bid Documents.
