PROJECT MANUAL MODIFICATIONS

- 2.1 Specification Section 260533 Raceways and Boxes for Electrical Systems
 - A. Part 2 Products, Article 2.1 Metal Conduit and Tubing, **DELETE** Paragraphs C, D, E, F & G in their entirety. All wiring shall be installed in Rigid Steel Conduit.
 - B. Part 3 Execution, Article 3.1 Raceway Applications, Paragraph B, **DELETE** Subparagraphs 1 and 2 in their entirety.
- 2.2 Specification Section 28 31 11 Digital Addressable Fire Alarm System
 - A. Article 2.1 Manufacturers; Paragraph A, ADD Model No. 5808 for the Silent Knight Standard of Design.
 - B. Article 2.12 Device Guards **DELETE** Paragraphs A, B and C in their entirety and **REPLACE** with the following paragraphs:
 - "A. DEVICE GUARDS
 - Safety Technology International, Inc. Models 9600/9700 as the Standard of Design and Construction.

CLARIFICATIONS/RFI'S

- 2.3 Delcollo Electric email: Tuesday, April 22, 2014
 - A. Need mounting method for the devices guards for smoke and heat detector in the drop ceiling on first floor.

Response: Mount 24"x 24", 22-gauge panel of sheet metal behind ceiling tile. Mount device guard using tamper proof screw/bolts and nuts.

- 2.4 Delcollo Electric email, dated May 1, 2014
 - A. The fire alarm panel in spec is Silent Night proprietary line. Need Direction.

Response: Model Number added to the specification for a non-proprietary system.

B. Note 2 on the drawing FA 102 talks about key. What does the key do? Do you need the key to set off the alarm or is the key just to reset the pull station?

Response: The key or keys are for the Correctional Officers to set the Alarm and then to reset the Pull Station. Standard operating procedure is for a Correctional Officer to visually check an alarm before setting off a general alarm and calling in the Fire Department.

- 2.5 Delcollo Electric question during walk-thru April 23, 2014
 - A. Can plenum rated wire be used above the 1st floor dropped ceiling?

Response: For bidding purposes use rigid conduit.
