Sealed bids for **OMB/DFM Contract No. MC3804000029 – Vaughn Correctional Center – Hi-Voltage Repairs – Re-Bid** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Thursday, June 27, 2103, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves preventative maintenance services to various electrical pieces of equipment at the James T. Vaughn Correctional Center located in Smyrna, Delaware. Includes but is not limited to: kV cables, transformers (with VFI, dry-type, and cast-coil), substations, switches, circuit breakers, lightning arrestors. Also demolition and proper disposal of one 750 kVA padmount transformer as shown on the contract documents.
