

## ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC3804000093 – Baylor Women’s Correctional Institution – Unit #7 – Shower Renovations** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Thursday, May 9, 2019, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the following at the Baylor Women’s Correctional Institution located in Wilmington, Delaware: renovation and expansion of the shower room to include new stud walls reinforced with marine grade plywood and stainless steel wall panels. Floors of the shower room will be finished with troweled epoxy resin floor system with integral cove base. Floors will be sloped to drain. New plumbing fixtures with ICON water metering systems will be installed. The laundry room adjacent to the shower room will also receive new troweled epoxy resin floor system and integral cove base. In both spaces, mechanical system will be upgraded and new lighting will be installed.

A **MANDATORY** Pre-Bid Meeting will be held on Friday, April 12, 2019, at 9:00 a.m. in the Facilities Management conference room in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. Representative of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**

Site visits will be scheduled separate from the pre-bid meeting. A security (background) clearance is required of all approved attendees intending to visit the site on the pre-selected date(s). Security Clearance forms will be handed out at the pre-bid meeting.

Sealed bids shall be addressed to the Division of Facilities Management, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901. The successful bidder must post a performance bond and payment bond in a sum equal to 100 percent of the contract price upon execution of the contract. The Owner reserves the right to reject any or all bids and to waive any informalities therein. The Owner may extend the time and place for the opening of the bids from that described in the advertisement, with not less than two calendar days notice by certified delivery, facsimile machine or other electronic means to those bidders receiving plans.
