

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC3806000012 – Sussex Violation of Probation – Security Upgrades** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Thursday, June 21, 2018, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the following at Sussex Violation of Probation located in Georgetown, Delaware: reinforcement of the exposed walls with bullet resistant fiberglass panels that comply with UL 752; existing reception area will remain in place; existing aluminum storefront glass will receive a clear bullet resistant laminate film that will increase its protection up to Level II as well as seven (7) exterior windows in two specific areas, reception and administration offices; both vestibule doors to receive remote release magnetic locks each.

A **MANDATORY** Pre-Bid Meeting will be held on Friday, June 1, 2018, at 9:00 a.m. in the Facilities Management conference room in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. Representative of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**

Site visits will be scheduled separate from the pre-bid meeting. A security (background) clearance is required of all approved attendees intending to visit the site on the pre-selected date(s). Security Clearance forms will be handed out at the pre-bid meeting.
