

## ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC3806000014 – Central Violation of Probation Center – Lobby Security Upgrades** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Thursday, November 8, 2018, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the following at the Central Violation of Probation Center located in Smyrna, Delaware: reinforcement of the exposed walls with fiberglass panels that comply with UL 752 in order to achieve the security BR (bullet resistant) level II rating. The office next to the lobby on the reception side wall will also receive the BR level upgrades. The renovation and expansion of the reception workstation will consist of a bullet resistant acrylic arched window storefront system and level II BR fiberglass board at casework and countertops. Exterior windows at the reception and administration offices, interior doors and sidelights will receive a level II clear BR laminate as well. Both pairs of vestibule doors to receive remote release magnetic locks.

A **MANDATORY** Pre-Bid Meeting will be held on Wednesday, October 17, 2018, at 9:00 a.m. in the Facilities Management conference room in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. Representative of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**

Site visits will be scheduled separate from the pre-bid meeting. A security (background) clearance is required of all approved attendees intending to visit the site on the pre-selected date(s). Security Clearance forms will be handed out at the pre-bid meeting.

Sealed bids shall be addressed to the Division of Facilities Management, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901. The Owner may extend the time and place for the opening of the bids from that described in the advertisement, with not less than two calendar days notice by certified delivery, facsimile machine or other electronic means to those bidders receiving plans.
