

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC4506000026 – Delaware State Police Troop 6 – Boiler Replacement** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Friday, March 22, 2013, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the following at Delaware State Police Troop 6 located in Wilmington, Delaware: remove existing boiler serving building HVAC system and replace with a new system consisting of two (2) high efficiency condensing boilers, pumps, piping, expansion tank, air separator and breaching. Project includes miscellaneous carpentry, mechanical, electrical, controls, insulation and balancing.

Attention is called to construction schedule as detailed in the Bid Documents.
