

## ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC4506000058 – Delaware State Police Troop 1 – Exterior Renovations** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Thursday, March 24, 2016, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project includes, but is not limited to, the following at Delaware State Police Troop 1 located in Wilmington, Delaware: removal of existing concrete slabs and handrails; removal and resetting of existing granite tread slabs; installing new anodized aluminum hand and guard rails on ramps and stairs; installing new reinforced concrete walls, curbs and walks; installing new concrete coatings.
