#### ADDENDUM NO. 2

The following items shall become a part of the contract documents. Contractor must acknowledge receipt of this addendum on the Bid Form. Failure to do so may subject the Bidder to disqualification.

- Item No. 1 Refer to Specification Section 00 41 13 BID FORM
  - Replace the Bid Forms pages 1 through 5 with the attached. Alternate No. 4 was added per below, and "HVAC Controls" was added to the subcontractor list.
- Item No. 2 Refer to Specification Section 01 23 00 ALTERNATES
  - At Schedule of Alternates, add the following:
    - D. <u>Alternate No. 4:</u> Price to remove and install new lighting and associated electrical work on the Second Floor as indicated in the bidding documents.
- Item No. 3 Refer to Specification Section 11 33 00 RETRACTABLE STAIRS, Article 1.5 WARRANTY, Paragraph A:
  - Replace the phrase "One year" with the phrase "Two year".
- Item No. 4 Refer to Specification Section 23 81 29 VARIABLE REFRIGERANT FLOW HVAC SYSTEMS:
  - Article 2.09, Paragraph A: Add the following subparagraph 4:
  - 4. The existing Johnson Controls Building Management System resides at the Delaware State Police Headquarters. The new variable refrigerant control system shall communicate with this existing interface through BACNET IP. The control contractor shall coordinate with DSP IT personnel to obtain the required IP addresses and security passwords to make the connection to Troop 9 seamless. The control contractor shall also be responsible for coordinating all connections and protocols required to obtain the information from the VRF system and deliver it to the Construction Maintenance Manager's Laptop/PC.

- Article 2.10, Paragraph Q: Add the following subparagraph 2:
- 2. ERV Units shall be controlled by an individual DDC controller on the Johnson Controls Building Automation network. The controller shall control fans, fan speeds, by-pass damper and monitor return, supply, exhaust and fresh air temperatures.
  - Article 3.3, Add the following Paragraph C:
- C. VRF Equipment Warranty: Contractor shall provide preventative maintenance during the 2-year warranty period. Maintenance shall include the following:
  - 1. Filter changes/cleaning on all indoor VRF equipment and ERV units every other month.
  - 2. Spring and Fall cleaning of the outdoor condenser coils per the manufacturer's recommendations.
  - 3. Check high and low voltage wiring connections on indoor and outdoor units.
  - 4. Verify the controls are working correctly.
  - 5. Record ambient temperatures and refrigerant pressures at each outdoor unit.
  - 6. Visually inspect the ERV heat exchanger cores for any dirt/blockage. Clean if necessary.
  - 7. Record any complaints from the building occupants regarding the HVAC System.
  - 8. Perform any tests required by the manufacturer to maintain the system warranty and proper operation.
  - 9. Contractor shall keep a record of the service report in a binder on site for review by the Owner's representative, as well as e-mail a copy of the report to the Owner's representative."
