

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC5511000009 – DelDOT South Wing Lab – HVAC/Exhaust Upgrades** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 3:00 p.m. local time on Thursday, November 13, 2014, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the following at the DelDOT South Wing Lab located in Dover, Delaware: replacement of the existing roof-top air handling units and the associated ductwork with new roof-top air handling units with new VAVs; new air handling units will be supported by new structural steel with a steel platform. Also included is the replacement of the existing BAS controls for the lab section of the building.

Attention is called to construction schedule as detailed in the Bid Documents.
