

## ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC5511000012 – DeIDOT Administration Building – West Wing Roof Replacement** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Thursday, June 23, 2016, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the following at the DeIDOT Administration Building located in Dover, Delaware: removing the existing roof systems in their entirety to roof deck; removing existing metal coping from roof parapet walls; providing and installing new cold-applied SBS modified bituminous membrane roof system and related ancillary components including manufactured metal coping.

A **MANDATORY** Pre-Bid Meeting will be held on Wednesday, June 8, 2016, at 10:00 a.m. in the bidders room of the DeIDOT Administration Building, 800 Bay Road, Dover, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**
